for Class Pre-Primary to Class VIII for a period of three years w.e.f. 06/3/20 to 05/03/2023

The above sanction is subject to fulfillment of following conditions:-

1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.
2. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009(Annexure I) and the Uttar Pradesh Right of Children to Free and Compulsory Education Rules, 2011(Annexure II).
3. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantage group in the neighbourhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.
4. For the children referred to in paragraph 3 the school if covered under section 12(2) of the Act, shall be reimbursed accordingly. To receive such reimbursements school shall provide a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child of his or her parents or guardians to any screening procedure.
6. The School shall not deny admission
 - (a) to any child For lack of age proof.
 - (b) on the ground of religion, caste or race, place of birth or any of them.
7. The School shall ensure that,-
 - (i) no child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school;

- (ii) no child shall be subjected to physical punishment or metal harassment;
 - (iii) no child is required to pass board examination till the completion of elementary education;
 - (iv) every child completing elementary education shall be awarded a certificate as laid down under Rule 23;
 - (v) inclusion of Students with disabilities/special needs as per provision of the Act;
 - (vi) the teacher performs its duties specified under section 24 (1) of the Act; and
 - (vii) the teacher shall not engage himself or herself for private teaching activities.
8. The School shall follow the syllabus on the basis of the curriculum laid down by the appropriate authority.
 9. The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.
 10. No unrecognized classes shall run within the premises of the school or outside in the same name of school.
 11. The School is run by a society registered under the Societies Registration Act, 1860 (21 of 1860) or a public trust constituted under any law for the time being in force.
 12. The School is not run for profit to any individual, group or association of individuals or any other persons.
 13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared as per rules. A copy each of the Statements of Accounts should be sent to Zila Shiksha Adhikari every year.
 14. The Recognition Code Number allotted to your school is...18163..... This may please be noted and quoted for any correspondence with this office.
 15. The school furnishes such reports and information as may be required by the Director of Education/Zila Shiksha Adhikari from time to time complies with such instructions of the State Government/local authority as may be issued to secure the contribution fulfillment of the condition of recognition or the removal of deficiencies in the working of the school.
 16. Renewal of Registration of Society, if any, be ensured.
 17. The School Management/Trust and staff shall abide by the direction of the State Government issued from time to time.
 18. Other conditions as per Annexure 'III' enclosed.
